PETITION FOR APPEAL

COMES NOW the Appellant, Leonard Tracy Clary, by and through the undersigned counsel, Fred D. Taylor, Esq., Participating Attorney for The Rutherford Institute, and submits pursuant to Va. Code § 2.2-4026 and Va. Supreme Court Rule 2:A:4, this Petition for Appeal. In support of this Petition, the Appellant alleges and avers as follows:

- 1. The instant Petition seeks review and reversal of the case decision of the Commonwealth of Virginia's Department of Motor Vehicles cancelling, recalling and demanding the return of license plates previously issued to the Appellant.
- 2. The Appellant is a resident of the County of Brunswick, Virginia, and jurisdiction and venue properly lies with this Court under Va. Code §§ 2.2-4003, 2.2-4026, and 8.01-261(a).
- 3. The case decision subject of the instant Petition is set forth in a letter to the Appellant from Richard D. Holcomb, Commissioner of the Department of Motor Vehicles dated September 4, 2015. A true and correct copy of this letter is attached to this Petition as Exhibit A.

- 4. Pursuant to Virginia Supreme Court Rule 2::2, the Appellant on September 30, 2015 timely filed with the Secretary of the Department of Motor Vehicles a Notice of Appeal of the case decision set forth in Exhibit A.
- 5. As grounds for this Appeal, Appellant hereby avers and alleges that the decision cancelling, recalling and demanding the return of the license plates, which are specialty license plates bearing the name and logo of the Sons of Confederate Veterans, is unlawful and was made without authority under the laws and statutes of the Commonwealth of Virginia.
- 6. Under Va. Code § 46.2-713, license plates issued by the Department of Motor Vehicles may be revoked, cancelled or repossessed only as "provided in this title" of the Code of Virginia.
- 7. The decision of the Department of Motor Vehicles as set forth in Exhibit A fails to cite any provision of Title 46.2 of the Code of Virginia authorizing or allowing the cancellation, revocation, or repossession of the Appellant's Sons of Confederate Veterans license plates.
- 8. Appellant alleges and avers that no statutory authority exists under Title 46.2 of the Code of Virginia or any other law of the Commonwealth of Virginia authorizing the cancellation, revocation or repossession of the Appellant's Sons of Confederate Veterans license plates.
- 9. The decisions and order of the United States Supreme Court and the United States
 District Court for the Western District of Virginia, referenced in Exhibit A, do not provide
 the Department of Motor Vehicles with legal authority to cancel, revoke and repossess the
 Appellant's Sons of Confederate Veterans license plates as said decisions only resulted in the

vacation and dissolution of an injunction requiring the Department of Motor Vehicles to issue Sons of Confederate Veterans license plates bearing the logo of that organization.

10. The case decision of the Department of Motor Vehicles cancelling, revoking and/or recalling the Appellant's Sons of Confederate License Plate is unlawful in that it is not in compliance with statutory authority, jurisdiction or right as provided in the laws governing the Department of Motor Vehicles and the cancellation of license plates as set forth in Title 46.2 of the Code of Virginia and other statutes and laws of the Commonwealth of Virginia.

WHEREFORE, Plaintiff requests that this Court enter a judgment reversing the decision of the Department of Motor Vehicles cancelling, revoking and/or recalling the Sons of Confederate Veterans license plates issued to the Appellant and declaring that the Department of Motor Vehicles is without authority to cancel, revoke or repossess those license plates.
